Srinivasan, Advisor, Wipro Ltd, Mr. Srikar M S, IAS, Commissioner of Commercial Taxes, Government of Karnataka, Mr. V Kiran, Vice President -Finance, TVS Motors, Mr. and Mr. Hanish S, Partner, HSKA & Associates & Member, Indirect Tax Committee who deliberated on topics such as the filing of tax returns in the new GST regime, ease of doing business, many concerns commonly faced in the industry as well as on specific topics such as the calculation of provisional ITC as per the new CGST

Members of the BCIC also, in February gathered to discuss another key driver of the economic health of a country – the 2020 Union Budget. With its many grass root reforms that aim to relieve India of its current negative symptoms as well as put the country at equal footing with others in terms of innovation, the budget was declared worthy of praise.

Another key facet of Karnataka's industrial growth was identified through international partnerships to promote local business and forge long lasting diplomatic ties. Two such interactive sessions, with the rapidly growing economies of the People's Democratic Republic of Algeria and Thailand were organized, during which Memorandum of

Understandings between diplomatic representatives of the countries and members of the BCIC were signed. These MoUs firmly establish India, and specifically Karnataka as a key piece of their South Asian growth story.

The events were graced by dignitaries such as H.E. Mr. Hamza YAHIA-CHERIF, the Hon'ble Ambassador of People's Democratic Republic of Algeria and His Excellency Jurin Laksanawisist, Deputy Prime Minister of Thailand.

Furthermore, to combat the distressing trend of unemployment as well as the growing need for innovation, skill development and up gradation, the BCIC organized an awareness session on Dual System Training and National Apprenticeship Promotion Scheme in collaboration with the Indo-German Programme for Vocational Education and Training (IGVET) that was represented by Jayarama T, Advisor for the Bengaluru cluster. The objective of this Dual System Training scheme is to conduct training programmes under high employability courses in order to fulfil the requirements of a skilled workforce.

Other programs organized with the same objective were an industry visit to the m2nxt, A BFW Subsidiary to witness working of IRIS, an AI device focused at elevating India's manufacturing segment to the level of the much hyped Industry 4.0 as well as an industry meetup on Edge Analytics chaired by Mr. Chetan Kumar S, Co-founder and C.E.O AiKaan Labs and Mr. Saravanan Radhakrishnan, Engineer at Cisco

Karnataka Tourism, one of the brightest and most important aspects of the state was also a key point of discussion, with efforts being made to discuss and resolve issues relating to the tourism, hospitality, real estate industries as well as address the impact of skill development and travel and tourism technology in the

Finally, a much awaited event that is the brainchild of BCIC'S Expert Start Up and Economic Affairs was launched. The team, under the leadership of Dr. L. Ravindran created the The BCIC Emerging Stars Awards, 2020 effort to offer a platform to startups in their bid to promote and reward entrepreneurial thinking, a key pillar of economic growth.

Interactive session with Consul General Mr. Guillermo Devoto, Consulate General and Promotion Centre of the Argentine Republic in Mumbai December 4, 2019

During the above interactive session, Mr. Devesh Agarwal, President, BCIC in his welcome address said that both India – Argentina have been cooperating in few areas, especially – textile, agriculture, food and energy sectors and with the ties having grown stronger both the nations are looking forward towards greater camaraderie and stronger trade relations.

The Consul General Mr. Guillermo Devoto, Consulate General and Promotion Centre of the Argentina Republic in Mumbai provided an update on the bilateral trade and said that Argentina companies are looking forward for a collaboration on electric vehicles where they see India as a partner for the future. He emphasized that the relationship is based on complementarity, where Argentina can help with food and energy resources for India's large population. He marked out services, information technology, tourism, mining and renewable energy as the potential areas to deepen the trade

ties between the two nations.

On Tourism, Mr. Devoto said that both the countries have to improve the relationships in tourism since there is a lot of potentials in tourism sector in both the countries. India is an attraction in Argentina because of its history, culture etc. North to South distance of 5000 kms. in Argentina has various landscapes like mountains, sea, plains, forests attract tourists from all over the world.

On winery, he said that there were over 1,500 wineries in Argentina. The two largest companies are Bodegas Esmeralda (which owns the widely exported brand Alamos) and Peñaflor (which owns another widely exported brand Bodegas Trapiche). Between the two of them, these companies are responsible for nearly 40% of all the wine made in Argentina. The Argentine wine industry is fifth worldwide in production and eighth in wine consumption, Mr. Devoto said. He further said that since there is a free trade agreement between India and Argentina on many goods, India can start exploring investing in Argentina on various sectors.

Participants were keen to collaborate with Argentina on the following areas:

- Mr. Srijan Vadhera said that BCIC can facilitate on collaboration with Argentina on wine and food.
- Mr. Devesh Agarwal said that Argentina Day can be celebrated in Bangalore by introducing Argentina wine and food festivals. BCIC Tourism Committee can work on this and would be happy to facilitate on exports/imports between both the countries. Trade enquiries can be routed through BCIC
- Mr. T R Parasuraman said that manufacturing sector is gaining momentum in Argentina, we can look at exchange programme between Argentina and Indian Engineers
- Mr. Manas Dasgupta said that since both the countries are

- strong in agriculture, technology in agriculture and skilling of farmers can be thought of. Procurement of IT products from Indian could be considered.
- Mr. Niranjan S Bhargava, Member, Tourism Expert Committee, BCIC briefed on the Visa issues and requested the Consulate to address on the same which he hoped would boost the tourism footprints.

Mr. T R Parasuraman, Sr. Vice President thanked Mr. Guilermo Devoto and Ms. Cecilia Risolo for sharing information on Argentina and offering various scope for Indian Business Community in Argentina.

The BCIC under the aegis of Industry 4.0 Expert Committee organized a Special Talk and Industry Visit in its endeavour of bringing in awareness on Industry 4.0 in driving manufacturing forward more efficiently and customer-centric while pushing beyond automation and optimization to discover new business opportunities and models

Mr. Jagannath, Member, Industry 4.0 Expert Committee, BCIC and VP and Business Head, m2nxt, A BFW Subsidiary presented on "Connected Factories IRIS" - Device titled IRIS: How a home grown device from an Indian MTB has taken the Industry 4.0 to the next level of manufacturing. About IRIS, Mr. Jagannath said that:

Technologically IRIS device embraces the latest embedded system with firmware to meet IP64 specification, remain insensitive toward cyber-attacks although sitting in cloud (a part from ON-PREMISE version) and can have data redundancy over 6 months' despite losing connectivity with cloud for whatever reason. This technology is CNC control brand agnostic and can work with every machine tool in the world. The high level encryption enables that data in the cloud is secured while the data is handled by world topmost cloud service providers.

This device extends itself to Automation control and can do a great amount of value addition by performance reports on shop floor when cells, lines are automated. A look at skill mapping of operators

which drives from fool proof to idiot proof on shop floor is something very interesting to learn at an affordable cost. Additionally, it also talks of OEE, MTBF, MTTR and many more. A simple way to progress in shop floor towards Digitisation to Digitalisation to Digital transformation from this device truly making it a paperless factory and bringing in document integrity with a whole lot of document management efficiency. A part from all of the above on achieving predictive maintenance and nearly have zero down time with this device creates a lot of interest. Finally, this will enable to connect shop floors and factories.

Workshop on "How to Calculate 10% Provisional ITC in Form GSTR-3B as per the New CGST Rule" on 10th January 2020

The Bangalore Chamber of Industry and Commerce, on 10th January, 2020 structured an interactive workshop on 'How to Calculate 10% Provisional ITC in Form GSTR-3B as per the New CGST Rule' under the aegis of its Indirect Taxes Expert Committee. The workshop, held at the CR Board, BCIC Office was organized in order to provide the members with clarity on the Rule 36(4) & GSTR-3 B of the Income Tax Act and gain understanding on the calculation of taxes as per the new CGST rules.

The session was steered by the speaker of the evening, Mr. Hanish S, Partner, HSKA & Associates & Member, Indirect Tax Committee after a warm and hearty welcome addressed to the members by Mr. Prithvi K K, Secretary General of BCIC.

The discussion started off with Mr. Hanish explaining Sections 16 and 17

of the Income Tax Act which talk about the availing of how credit, the conditions on which it depends, the last date for availing credit and effect of the GST cash crunch and recession on credit availability.

Mr. Hanish also led lively discussions on the new CGST rules with the aim of bringing in clarity and resolving confusons. He stated that the 120% criteria under the new CGST Rule as being not a boon but a bane to taxpayers, and advocated this view through the employment of data and statistics, stating that the extra 20% was subject to other conditions and kept the taxpayers from availing 100% credit which they were originally entitled to do.

He then went on to resolve some practical difficulties faced by the audience such as checking for the 20% ad hoc extra credit for which he said the best resolution was to act on an invoice basis and the rules a taxpayer must adhere to in order to devise this amount.

He then shed light on the comparison between GSTR 2A & GSTR 3B,

showcasing the similarities and more importantly the differences under both the rules and how the taxpayers could tackle these differences when filing returns. Situations such as the complete match, partial match, no entry in books and no entry in 2A but in books were highlighted and the tax filing procedure in each case was laid down by him.

Mr. Hanish also explained the 83% Rule under the GSTR 3-B of the Income Tax Act and why the 20% has to be linked to an invoice in order to devise it. Account Entries which have always been quite the task were also simplified by him through a detailed presentation for the members to take note of in order to make the process less tedious. The presentation also communicated the statutory conditions to be kept in mind in order to ensure maximum compliance in the returns filed.

Lastly, Mr. Hanish welcomed questions and doubts from the audience which led to an engrossing debate. The members raised several questions on the what the 83% rule was, on how to file taxes to avail 100% credit, the 180 days' criteria for availing credit, exemptions that the taxpavers could benefit from. ineligible accounts, etc. The questions were taken up and answered with quite the vigor making the workshop just the right kind of interaction to clear up the cloud of confusion for the members on calculation of the 10% provisional ITC under the new GSTR 3-B rule of the act. ■

Awareness Session on Dual System Training and National Apprenticeship Promotion Scheme January 14, 2020



BCIC Members at the Awareness Session on Dual System Training and National Apprenticeship Promotion Scheme January 14, 2020

The Bangalore Chamber of Industry and Commerce under the aegis of its Manufacturing Expert Committee organized an awareness session on Dual System Training and National Apprenticeship Promotion Scheme on January 14th 2020 at the BCIC CR Board Room. The session was structured to bridge the disconnect between ITI trainees' learning outcomes and the current industry requirements.

The session began with cordial greetings from Prithvi K K, the Secretary General, BCIC and was steered by Jayarama T, Indo-German Programme for Vocational Education and Training (IGVET), Advisor-Cluster Bangalore.

Mr. Jayarama briefed the members on the objective of the DST scheme that is to enable industries and establishments to partner with Government and Private ITIs to conduct training programmes under high employability courses. The intention of the said courses is to fulfil skilled manpower requirements with the vision of strengthening Industry linkages and acquainting students in ITIs with latest technologies used in the Industry. The DGT encouraged ITIs to participate in the DST program to aid ITI trainees in becoming industry ready.

He then went on to discuss the criteria for eligibility of affiliated ITIs from both the government and private sectors to conduct DST and that for industries to avail it. The duration of training under this scheme can also be decided upon by the Industries and the ITIs jointly, he said.

Mr. Jayarama also went on to discuss the terms of agreement through a Memorandum of Understanding (MoU) that has to be signed by the Industry and the ITI as per DST guidelines. This MoU would lay down terms such as trade units, number of trainees required and the duration of the training period keeping in mind the timelines for

completion of the course curriculum. The responsibilities of both the ITIs and the Industries were laid down for the clarity of the members. The process flow from MoU to certification was also specified.

The Apprenticeship Program and its benefits were further presented by touching on the demand and supply of apprenticeship in India, its importance to employers, the current employment scenario in India, and also through a detailed case study of Airbus' apprenticeship program that was successfully carried out in the UK.

National Apprenticeship Promotion Scheme (NAPS) on the other hand was explained as a scheme that entails sharing of 25% of the prescribed stipend subject to a maximum of Rs. 1500/- per month per apprentice with employers and sharing of cost of basic training with Basic Training Providers (BTP). He further explained the process for registration and the criteria, the amount and the frequency at which the participating industries could expect reimbursements from the government for the training stipends paid

Mr. Jayarama then invited questions from the members. These questions pertained to a number of factors such as the eligibility criteria, types of Industries, registration process, reason for the employee workforce ratio in India, how to implement DST and NAPs, etc. Mr. Jayaram patiently responded to all questions to ensure that members left the event with clarity and confidence.

Lastly, a success video story of their efforts was showcased, which concluded the session on a powerful note. ■

He then opened the discussion by stating the micro and macro ramifications of the ongoing civic concerns in Bengaluru particularly those pertaining to lack of Infrastructure, non-maintenance of roads, garbage disposal, effective assessment and collection of property taxes.

The Traffic situation in places like Koramangala, Mysore Road, Dairy Circle, Hebal Road, etc has been a continuous menace to the residents

of neighbouring areas. Mr. Devesh Agarwal & Mr. Tyagu Valiappa brought this concern to the notice of the Mayor and called for civic agencies to work on

- Creating diversions
- Wrapping up the ongoing digging work for metros sooner
- Stern actions by the Traffic Police to reduce traffic violations by delivery agents
- Inputs from Public to reduce traffic
- The Outer Ring Road Metro
- Introducing the Suburban Railway
- Faster progress of the Airport Metro Project.

The Mayor then took to the podium to address these concerns. He stated that Government bodies have come a long way from the time when there was an acute lack of coordination between them, and are continuously working towards establishing better coordination among the BWSSB, BBMP and BESCOM to redress and resolve these roadways and traffic related issues at the earliest. He

informed the members of the current initiatives taken, such as a sitting of the members every 10 days, continuous communication over whatsapp groups, hiring of zonal contractors for patch work of the roads, and are working on increasing the allocation of funds towards roads & railways.

He mentioned that the population boom and rapid growth in the city was beyond their imagination. They are however, he said, working earnestly to resolve infrastructure issues.

The next topic for discussion was waste & debris management and the water logging issue faced by the Bangaloreans. The Hon'ble Mayor and the Chairman of BWSSB assured members of the ongoing work on the Drainage Recharge Pit Project to control the damage caused during manufacturing of the concrete drain base. He also mentioned the continuous work taking place to dispose of sewage in order to avoid hassles due to clogging of rainwater during heavy rains. He also requested industries to ensure proper disposal of waste from their end.

Finally, the Hon'ble Mayor assured complete assistance to sort out miscellaneous issues such as the bus menace in town, the illegal parking crisis, plastic ban and packaging material control by taking them up with the concerned authorities.

Members also requested for financial transparency, prioritization of roads and railways over metros, made a

Workshop on Power Market and Exchange January 24, 2020

The Energy, Environment and Water Expert Committee of The Bangalore Chamber of Industry and Commerce (BCIC), in association with Indian Energy Exchange (IEX) organized a half day workshop on power market and exchange on the 24th of January 2020 at the Hotel JW Marriott, Bengaluru.

The session began on a hearty note with Mr. Devesh Agarwal, President, BCIC extending a warm welcome to the esteemed speakers from IEX and the BCIC members present at the event. He spoke of how electricity is a crucial requirement for citizens, and the ensuing pressure on the government & power companies to satiate power generation needs. Hence, continuous efforts must be made by both users and equipment manufacturers to increase efficiency

in usage of electricity. Mr. Devesh commended the IEX for taking the initiative to conduct this workshop in order to create awareness on the management of electricity demand in India.

He concluded his speech by inviting Mr. Ramesh Saligrama, Chairman of Energy, Environment and Water Expert Committee, BCIC to express his views on the power crisis in the state.

Mr. Saligrama then took to the stage to express his gratitude towards the IEX for their continued efforts to address the energy and power exchange issues of the members. The main objective of the meeting, as stated by him, was to understand the current regulations on power in the country and how the members may seek advice in order to ensure maximum utilization of available energy resources at competitive pricing. An issue that must be prioritized was the absence of platforms for the exchange of renewable energy. He requested IEX speakers to focus on carbon neutrality compliance and help set up an energy ecosystem in the country which would ensure the availability of renewable energy at reasonable prices.

The Speakers from Indian Energy Exchange viz. Mr.Rohit Bajaj, Senior Vice President, IEX and Mr. Nitin Sabikhi, AVP, IEX delivered their speeches therein.

Mr. Rohit explained the Indian power sector and threw light on the generation, transmission, and distribution channels employed. Over the past decade, he stated that, energy deficit had decreased from 10% to 0.7%. This, coupled with an expected increase in the demand for power by 5.5% over the next 5 years is

testimony to the potential of the power sector. Issues for Open Access were discussed, some of the major ones being the high cross subsidy surcharge, high additional surcharge and long activation time. To conclude, Mr. Rohit explained the upcoming products of exchange which are real time market, long duration Contracts, Green-TAM and gross bidding.

The trading mechanism was then explained by Mr Nitin, who spoke of the allotment of contracts and how the price is calculated on the exchange platform.

Afterwards, Mr Anish Regional Manager, IEX, Karnataka elaborated on the power scenario of Karnataka and on portfolio management. He explained the buy and sell trend being pursued by discoms and open access consumers and also discussed the savings that can be availed by open access consumers while trading on IEX platform.

The session concluded with questions from the audience which were addressed by the esteemed speakers. The interaction was thus, extremely fruitful and imparted knowledge for the members to implement in order to maximize energy utilization.

It could be hybrid, electric, fuel cell, hydrogen, or any other technology which is still unimagined today. State Governments have a significant role in encouraging the penetration and adoption of ZEVs since they control road taxes and permits. Sadly, Karnataka has some of the highest road taxes in the country, Presided, BCIC added. Being an open supporter of lean innovation and advocator of green policies, he said that EVs can revolutionise transportation globally and the way to go for India in the automobile sector.

proposal of hiring more EV buses for BMTC; Develop EV cluster in the State and dedicated fund for EV mobility / manufacturing sector, the Minister further added.

Summing up the deliberations, Mr. TR Parasuraman, Senior Vice President, BCIC said that the Indian automobile industry being one of the biggest contributors to India's GDPis strongly focused towards the "Make in India" initiative of Government of India and the EV initiative wouldfurther enable to achieve global manufacturing standards in the country. This will also create a convivial environment for foreign investors to further invest in the State, he further added.

The Session concluded with a lively interaction. The event was attended by the Captains of the Industries in large numbers. ■
