

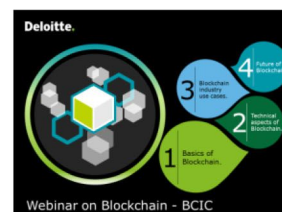
Webinar on BLOCKCHAIN
